Clubs/Teams shall ensure that accused players and club/team officials appear for their Disciplinary Hearing. The player's/team official's ONTARIO SOCCER registrant book shall be presented at a hearing, when requested by the Discipline Committee.

Except in cases of ONTARIO SOCCER Misconduct Type 1.3, 1.5 and 1.6, an individual who is subject to the Discipline by Review (DBR) System shall have the right to request to be disciplined by the Discipline by Hearing System. The accused shall submit a written request to the League within three (3) days of receiving the dismissal.

Any party required to attend a hearing may request one (1) postponement of a hearing. The party must submit a written request which must be received by the PISL no later than four days prior to the date of that hearing, stating the reason for requesting the postponement. All such requests must be accompanied by the correct fee. Should the request be denied, the fee shall be refunded. The PISL shall have full discretion to refund the "Request For Postponement Fee" if sufficient reason warrants such action.

An accused less than eighteen years of age must be accompanied by an adult, who shall act as an adviser, failing which the hearing will not proceed and the accused shall be suspended until the hearing is held.

Each party required to attend a Discipline Hearing is entitled to have an adviser in attendance at the Discipline Hearing. The adviser may not act as a witness nor provide any testimony at the Discipline Hearing. They may not question the competence of the game official(s) and may question a witness for clarification purposes only.

Each party required to attend a Discipline Hearing is entitled to have a maximum of two (2) observers in attendance at the Discipline hearing in order to ensure that a specific party receives a fair hearing. They may not act as a witness nor provide any testimony but may speak at the discretion of the Discipline Hearing Panel.

Each party required to attend a Discipline Hearing is entitled to bring witnesses who must appear in person. Written reports by witnesses are not acceptable.

Each party required to attend a Discipline Hearing is entitled to receive within 48 hours upon submitting a written request to the League a copy of the Report(s) of Misconduct and all documentation which will be considered by the Discipline Hearing Panel.
